ABOUT WASHINGTON HEALTHCARE ACCESS ALLIANCE

Washington Healthcare Access Alliance provides leadership and support to Washington State's healthcare safety net, prioritizing the work of free and charitable healthcare efforts.

MISSION

Our mission is to strengthen and support the free and charitable clinics of Washington through professional networking, advocacy, and education.

WHAT ARE FREE AND CHARITABLE CLINICS?

"Free" and "charitable" are definitions established individually by each clinic, and refer to nonprofit clinics that provide healthcare services regardless of the patient's ability to pay.

Some clinics bill Medicaid, some have sliding fee scales that start at zero, and many accept no payment whatsoever. Nearly all of Washington's free and charitable clinics are staffed primarily by volunteers.

Washington State free clinics provide a wide range of services, including medical, dental, vision and behavioral healthcare, chronic disease management, social services, specialty care referrals, physical and occupational therapy, and health behavior change programming. Most of the clinics are site-based; however, some provide mobile services, which helps to meet the needs of rural, isolated communities.

WHY SUPPORT THIS EVENT?

The Washington Free and Charitable Care Conference is the only free clinic conference in the Northwest. The purpose of the event is to connect free clinic leadership, staff and volunteers with resources and networking opportunities to strengthen the free clinic network.
